If L-1 is not an MSE and MSE Service Provider (s) has/have quoted price within L-1+ 15% of margin of purchase preference /price band as defined in the relevant policy, then 100% order quantity will be awarded to such MSE bidder subject to acceptance of L1 bid price. Benefits of MSE will be allowed only if the credentials of the service provider are validated on-line in GeM profile as well as validated and approved by the Buyer after evaluation of submitted documents.
6. Estimated Bid Value indicated above is being declared solely for the purpose of guidance on EMD amount and for determining the Eligibility Criteria related to Turn Over, Past Performance and Project / Past Experience etc. This has no relevance or bearing on the price to be quoted by the bidders and is also not going to have any impact on bid participation. 2. **Generic**

Option Clause: Excess Settlement. Service providers must declare the applicability of additional charges during invoice creation and submit mandatory supporting documents to avail this option. The total invoice amount, including additional charges, shall not exceed the agreed-upon excess settlement percentage for the order.

1. BovineSNP50 v3 BeadChip genotyping using illumina ISCAN platform or other platforms with an up to date iScan Control and Illumina GenomeStudio Softwares
2. Bidder must have in-house genotyping facility in India (Illumina installation certificate to be provided). Samples should not be sent out of India.
3. NABL & DSIR accreditation is mandatory.
4. The company should have a Bioinformatics facility for genome analysis and QC generation.
5. Proof of experience with respect to the genotyping in terms of purchase orders specific to the genotyping in the illumina platform must be submitted. Also the experience in the isolation of nucleic acids from animal cells/tissues for genotyping must be submitted.
6. Genotyping results should be provided in 3-4 weeks' time.
7. DNA isolation and Quality assessment from all tissues (blood/hair/milk/cells/tissue) should be included in the quote.
8. Free of cost transportation should be provided in dry ice.
9. The results should be provided both online and in suitable hard disc, without any additional cost. Results Data to be provided must include-machine QC certificate, primary data, DNA QC, genotyping QC, Genotyping results in (ATGC format and AB format), required annotation files) and all other relevant soft files amenable to downstream analysis

13. Reference of conditions published on any external site or reference to external documents/clauses.
14. Asking for any Tender fee / Bid Participation fee / Auction fee in case of Bids / Forward Auction, as the case may be.
15. Any ATC clause in contravention with GeM GTC Clause 4 (xiii)(h) will be invalid. In case of multiple L1 bidders against a service bid, the buyer shall place the Contract by selection of a bidder amongst the L-1 bidders through a Random Algorithm executed by GeM system.
16. Buyer added ATC Clauses which are in contravention of clauses defined by buyer in system generated bid template as indicated above in the Bid Details section, EMD Detail, ePBG Detail and MII and MSE Purchase Preference sections of the bid, unless otherwise allowed by GeM GTC.
17. In a category based bid, adding additional items, through buyer added additional scope of work/ additional terms and conditions/or any other document. If buyer needs more items along with the main item, the same must be added through bunching category based items or by bunching custom catalogs or bunching a BoQ with the main category based item, the same must not be done through ATC or Scope of Work.

Further, if any seller has any objection/grievance against these additional clauses or otherwise on any aspect of this bid, they can raise their representation against the same by using the Representation window provided in the bid details field in Seller dashboard after logging in as a seller within 4 days of bid publication on GeM. Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.

All GeM Sellers / Service Providers are mandated to ensure compliance with all the applicable laws / acts / rules including but not limited to all Labour Laws such as The Minimum Wages Act, 1948, The Payment of Wages Act, 1936, The Payment of Bonus Act, 1965, The Equal Remuneration Act, 1976, The Payment of Gratuity Act, 1972 etc. Any non-compliance will be treated as breach of contract and Buyer may take suitable actions as per GeM Contract.
