## GENERAL INFORMATION AND OTHER TERMS & CONDITIONS OF THE CONTRACT

- 1. The period of contract of Coconut trees would be for eleven months.
- 2. The Harvest should be removed from the period 8.00 am to 4.00 p.m.
- 3. The Bidder shall submit a Demand Draft drawn in favour of "ICAR UNIT: NATIONAL DAIRY RESEARCH INSTITUTE, payable at Bengaluru of Rs.7000/- along with filled Quotation as Earnest Money Deposit. If he fails to take up the work order/commence the work the E.M.D will be forfeited after issue of award. The EMD in full will be refunded to the unsuccessful bidder.
- 4. The leaves of coconut trees should not be removed without prior permission.
- 5. The successful bidder should deposit an amount equal to 10% of the Contract value towards security deposit. The security deposit shall be retained by the NDRI till completion of contract work. On successful completion of the contract work, the security deposit will be returned without any interest on submission of original receipt duly deducting damages if any caused. In the event of committing any breach of contract, the Security Deposit shall be liable for forfeiture.
- 6. All personnel engaged by the Contractor required abiding by the security regulations during their presence in the NDRI premises including Quarters and administration building area.
- 7. The contractor shall be liable to compensate NDRI or its employees or residents in the Campus for any loss or damage/injury caused by him or his labour or his representative due to the negligence causing injury or damage to them or the properties of the NDRI/employees/residents of qtrs.
- 8. The contractor shall be solely responsible to compensate his labour/agents in the event of any injury caused to them in the course of execution of the contract work.
- 9. The competent authority has the right to dispense with the contract awarded if the contractor fails to comply with the above conditions.
- 10. The Contractor should observe all safety precautions in the execution of the work.
- 11. The Contractor will be given necessary Gate Pass/Entry Pass wherever required for his labour for smooth execution of the work.

- 12. The Institute will not be responsible for the theft, fire, natural calamities and other damages and it will be the responsibility of the contractor to arrange for the security during the contract period.
- 13. The Successful bidder should deposit Quoted amount along with GST, Income Tax or any Taxes as applicable within in 10 days from the date of Tender/Quotation opening to award contract and to execute agreement.
- 14. The successful Quotationer will have to enter into detailed contract Agreement with NDRI/Bangalore on non-judicial stamp paper of Rs.100/-.
