Quotations are invited on behalf of Director, ICAR-NDRI for disposal of 103 Animals (04 Deoni Cows , 17 Deoni Male Calves, 03 Deoni Bulls, 14 HFX Cows, 31 HFX Male Calves, 03 HFX Female Calves/Heifers, 09 Malnad Gidda Cows, 12 Malnad Gidda Female Calves and young ones, 10 Malnad Gidda Male Calves and young ones which are Surplus at this Institute on the basis of offers received from the Goshalas Registered under the Mysore Societies Registration Act 1961 or any Association or body of persons to establish Institutions for taking care of cows or other animals. Such Goshalas interested in procurement of these animals may submit their offers in Lump sum basis on or before **2.00 PM on 07.03.2023**. Interested bidders may read the enclosed terms & conditions and if, so desired, can have inspection of the animals during office hours before submitting the offers. The quotation may be addressed to Head, SRS of NDRI, Bangalore and deliver the same in the tender Box available in Administration of the Institute.

### TERMS AND CONDITIONS

*and adjacent state*

1. Gaushalas/Trust should be located within the state of Karnataka, *and adjacent state* and in possession of a valid registration number and should have been functional at least for the past 3 years.
2. Should have at least 50 adult animals with adequate shelter, fodder resources, water resources and healthcare facilities and other essential infrastructure.
3. Should have adequate land for fodder production or as grazing land either as own land or on lease basis.
4. A team from SRS of ICAR-NDRI, Bangalore will make a visit after prior intimation to the provisionally selected Goshala for an inspection of your establishment and facilities etc.
5. After receiving the Office Order for lifting of animals from SRS of ICAR-NDRI, Bangalore, the concerned party/ Goshala should make their own arrangements (animal handlers, rope, suitable animal transport vehicle, permission for transport of animals etc.) for lifting of animals within 15 days from the date of order. The station/institute will not be responsible for any damage to property/man/animals during loading and transport.
6. Failing to lift the animals within 15 days from the date of order, the concerned party/Goshala will be charged Rupees 200 per day per animal towards feed and management cost for maintaining animals at our station and the same will be deducted from your Security Deposit.
7. Selected party/Goshala should submit an Agreement Letter in the given enclosed format in a suitable Govt. Stamp Paper (bond paper) before lifting the allotted animals.
8. **Bidder has to submit Bid Security of Rs.15,000/- alongwith the bid which will be refunded after award of order to the successful bidder.**
9. Further, if the animal is not lifted beyond 15 days from the date of order there allotments to lift the animal will automatically stands cancelled followed by forfeiting of Security Money
10. In case, as per order, any listed animal dies by any means (i.e. illness/accidental death etc.) at our farm before lifting by the selected party/Goshala, the reserve price fixed for that particular animal(s) will be refunded to the party/Goshala, on the recommendation of the I/c LRC.
11. Copies of all the relevant documents related your Goshala should be enclosed.
12. The selected Goshala/party should deposit full amount of quoted price before lifting animals.
13. After lifting of animals from the station, it is the duty and responsibility of the concerned party/Goshala to maintain the animals as per the standard/recommended management practices and strictly none of the animals should be sent for slaughter. Any deviation from this point, the concerned party/Goshala is only responsible for any action/queries in future by any other agency or parties. The SRS of ICAR-NDRI, Bengaluru or the institute ICAR-NDRI as a whole will not be responsible for any of your deviation/action against you/your Goshala.

3. I/We will feed nutritious food, provide good shelter healthcare and maintain sufficient grazing glands for all the cattle.
4. I/We will fully abide by the State and Central Government rules and regulations regarding Goshala maintenance, Cow Protection and Animal Welfare.
5. I/We may donate/sell the animals only after a period of one year from the date of lifting of animals from your station. Animals will be given purely for agriculture/rearing purpose only and for the benefit of genuine local farmers (certified by the local government bodies) living around the Goshala after signing a suitable documents and/or legal agreement with them.
6. I/We will collaborate and work closely with local registered Goshala or Government agencies for further development and better protection of these cattle.
7. I/We fully aware and agree that, it is our duty and responsibility to maintain the animals as per the standard/recommended management practices and strictly none of the animals will be sent for slaughter. 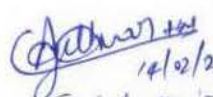
