OFFICE ORDER

In pursuance of Council's Memorandum F. No. 6(1)/2023-Per.II dated 21-08-2023, the Director, ICAR-NDRI, Karnal is pleased to allow Dr. Sanjay Kumar Ray, SMS, KVK-Nadia, ERS of ICAR-NDRI, Kalyani, WB to join his duties to the post of Senior Scientist-cum-Head, KVK, Nadia-II under ICAR-NDRI, Karnal in the afternoon of 21st August, 2023 in Pay Level-13A (Rs. 131400-Rs. 217100) on the following terms:

- 1. The pay scale of the post is Pay Level-13A (Rs. 131400-217100) with rationalized entry pay Rs. 1,31,400/-.
- 2. The Council follows the pension rules as formulated by the Govt of India vide letter No. 38/16/2001P&PW-(A) dated 09.12.2003 and subsequent clarification of OM No.28/30/2004P&PW-B dated 26.07.2005 and 28.10.2009. Further, his service will be regulated under NPS System (2003).
- 3. The TTA/ joining time etc. will be governed as per provisions under the supplementary Rules 114.
- 4. The Headquarter will be at ICAR-National Dairy Research Institute, Karnal for the present but he will be liable to be transferred anywhere in India against the vacant post of Senior Scientist-cum-Head, KVK under different ICAR institutes in terms of Council's guidelines issued vide O.M. No.38(10)/2017-Pers.IV dated 06.07.2018. However, he will not be permitted to seek transfer until and unless a minimum period of five years of service in the initial place of selection/ posting is completed. If the Council receives any request from him or anyone acting on his behalf relating to his transfer within this period, the Council will deem it as violation of this condition and will be free to withdraw the offer/terminate the appointment while under probation/ initiate departmental proceedings without any further reference.
- 5. He will be on probation for a period of two (2) years from the date of appointment which may be extended at the discretion of the Competent Authority. Failure to complete the period of probation to the satisfaction of the Competent Authority will render him liable to reversion to his present department.
- 6.He shall give an undertaking in the prescribe proforma to the effect that patent right in respect of the discoveries and inventions and the technical and engineering "Know-How" of processes that may develop during the course of his services with the ICAR, shall vest in the ICAR.
- 7. Other condition of the service including pension will be governed by the relevant Rules/Orders/ Staff Regulations which may be issued by the ICAR/ Govt. of India from time to time. The appointment is subject to the rules of A.R.S. and Rules & Bye-Laws and regulations of the ICAR Society.

8. If any declaration given or information furnished by him proves to be false or he is found to have willfully suppressed any material information he will be liable to removal from service and such other actions as may be deemed necessary.
