1. The minimum average annual financial turnover of the bidder during the last three years, ending on 31st March of the previous financial year, should be as indicated above in the bid document. Documentary evidence in the form of certified Audited Balance Sheets of relevant periods or a certificate from the Chartered Accountant / Cost Accountant indicating the turnover details for the relevant period shall be uploaded with the bid. In case the date of constitution / incorporation of the bidder is less than 3-year-old, the average turnover in respect of the completed financial years after the date of constitution shall be taken into account for this criteria.

2. 3. **Purchase preference to Micro and Small Enterprises (MSEs):** Purchase preference will be given to MSEs having valid Udyam Certificate and whose credentials are validated online through Udyam Registration portal as defined in Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 dated 23.03.2012 issued by Ministry of Micro, Small and Medium Enterprises and its subsequent Orders/Notifications issued by concerned Ministry. If the bidder wants to avail themselves of the Purchase preference, the bidder must be the manufacturer / OEM of the offered product on GeM. In respect of bid for Services, the bidder must be the Service provider of the offered Service. Traders are excluded from the purview of Public Procurement Policy for Micro and Small Enterprises and hence resellers offering products manufactured by some other OEM are not eligible for any purchase preference. Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered product or service, and Buyer will decide eligibility for purchase preference based on documentary evidence submitted in case of product bids, whereas in case of services the eligibility is automatically validated. The buyers are advised to refer the [OM_No.1 4 2021_PPD_dated_18.05.2023](#) for compliance of Concurrent application of Public Procurement Policy for Micro and Small Enterprises Order, 2012 and Public Procurement (Preference to Make in India) Order, 2017. Benefits of MSE will be allowed only if seller is validated on-line in GeM profile as well as validated and approved by Buyer after evaluation of documents submitted.

4. Estimated Bid Value indicated above is being declared solely for the purpose of guidance on EMD amount and for determining the Eligibility Criteria related to Turn Over, Past Performance and Project / Past Experience etc. This has no relevance or bearing on the price to be quoted by the bidders and is also not going to have any impact on bid participation. Also this is not going to be used as a criteria in determining reasonableness of quoted prices which would be determined by the buyer based on its own assessment of reasonableness and based on competitive prices received in Bid / RA process.

1. Generic

OPTION CLAUSE 25% : The buyer can increase or decrease the contract quantity or contract duration up to 25 percent at the time of issue of the contract. Name of Work: Whole Genome (DNA) based breed-specific variant detection and bioinformatic analysis services for Cattle samples

Scope of Work

1. Sample processing and quality control -

- Whole blood samples in EDTA vials will be given and the vendor has to arrange pickup from the designated area (anywhere in India) by himself. Approximate number of blood samples will be 50-60. Failed samples after QC check must be collected without additional charges.
- Acceptance parameters for extracted DNA: $\geq 1 \mu\text{g}$ per animal, Verify DNA quality: A260/280 ratio 1.8-2.0; A260/230 ratio ≥ 2.0 ; Assess DNA integrity and concentration using standard fluorometric and electrophoretic methods

2. High-Throughput Sequencing and DNA Fragment Analysis

- **Read Configuration:** Illumina Paired fragments from both ends, minimum 150 bases per read through Illumina high-throughput sequencing platform
- **Insert Size:** 300–500 base pairs
- **Target Depth:** 10-15 fold average coverage (10-15x) relative to latest cow reference genome (latest NCBI/ENSEMBL assembly)
- **Data Quality:** Minimum 90% bases with quality score $\geq Q30$

3. Data Processing and Variant Detection

3.1 Primary Processing

- Perform quality assessment and adapter trimming
- Generate cleaned, high-quality compressed read files
- Produce sorted, duplicate-marked binary alignment files with index
- Compute alignment metrics: mapped reads, average depth, breadth of coverage

3.2 Variant Identification and Annotation

- Detect single nucleotide polymorphisms (SNPs) and short insertions/deletions (INDELS) using validated bioinformatic pipelines
- Apply quality filtering based on depth, mapping quality, and allele balance
- Annotate variants with gene names, functional consequences (synonymous, non-synonymous, intronic, intergenic), and predicted effects
- Provide per-sample summary: total variants, heterozygosity rate, transition/transversion ratio

3.3 Population-Level Analysis

- Merge variants across all 50 animals into a unified dataset
- Calculate allele frequencies and identify breed-specific variations
- Perform functional enrichment analysis (Gene Ontology and pathway annotation)

4. Deliverables

- All raw data files in standard format
- Cleaned read files (compressed standard format)
- Alignment files (binary format with index)
- Variant catalogue (standard variant call format, filtered)
- Quality control summary: DNA quality, read statistics, coverage metrics
- Merged variant dataset with allele frequencies
- Annotation tables: functional classification, gene impacts
- Summary reports with tables and visualizations
- Bioinformatic analysis report

5. Data Delivery and Confidentiality

- **Mode:** Secure encrypted external storage device (without additional cost)
- **Timeline:** Complete delivery within 10 weeks from sample receipt
- **Confidentiality:** All data treated as confidential and used solely for research purposes under ICAR-NDRI project
- **Data Retention:** Service provider shall maintain backup for 90 days post-delivery

6. Bidder Eligibility Criteria

- I Operational high-throughput DNA sequencing and analysis facility with proven capacity for ≥ 100 mammalian-sized genome analyses annually
- I Minimum two completed projects involving nucleotide-level variant profiling in livestock/human (documentary evidence required)
- I Dedicated in-house bioinformatics team with ≥ 3 years' experience in large-scale DNA variation analysis
- I Years of Past Experiences of same/similar services: last three (03) years, in any central/state PSU(s)/Government Department(s), Government in the central / state of India.
- I Past experience of similar services and Satisfactory report from past service buyer last 3 years (ending month of march prior to the bid opening): the bidder must have executed/ completed similar services (to any central/state PSU(s)/ Government Department (s), Government in the central) over the last 3 years (upload relevant work order as well as satisfactory work completion certificates from respective buyer). This can be any one of the following:
 - I Valid Lab certificate for service: Bidder must have ISO/NABL certificate.
 - I The Office of the service provider must be located in India. (Documentary evidence to be submitted)
- I Bidder financial standing : the bidder should not be under liquidation, court receivership or similar proceedings should not be bankrupt.
- I The bidders should not have been indicted for any criminal, fraudulent or corruption activity and not have been blacklisted by any Central/State Govt./Semi Govt./PSU/Autonomous body. Bidder has to upload undertaking with bid.

अस्वीकरण/Disclaimer

The Additional Terms and Conditions (ATC) have been incorporated by the Buyer after approval of their Competent Authority. The Buyer, is solely responsible for the impact of these clauses on the bidding process, its outcome, and consequences thereof including any restriction arising in the bidding process due to these ATCs and including the modification of technical specifications and / or terms and conditions governing the bid. All representations / grievances pertaining to the ATC clauses shall be raised with the buyer organization directly and not with GeM. If any of the clause(s) is/are incorporated by the Buyer regarding the following, the bid & resultant contract shall be treated as null & void. Further, GeM reserves the right, at its sole discretion, to cancel the bid forthwith, without issuance of any prior notice or intimation :-

8. Seeking experience from specific organization / department / institute only or from foreign / export experience.
9. Creating bid for items from incorrect categories.
10. Reference of conditions published on any external site or reference to external documents/clauses.
11. Asking for any Tender fee / Bid Participation fee, as the case may be.
12. Buyer added ATC Clauses which are in contravention of clauses defined in bid detail section, including specifications, EMD Detail, ePBG Detail and MII and MSE Purchase Preference sections of the bid, unless otherwise allowed by the applicable GeM GTC.
13. Any ATC clause in contravention with GeM GTC Clause 4 (xiii) (h) will be invalid. In case of multiple L1 bidders against a service bid, the buyer shall place the Contract by selection of a bidder amongst the L-1 bidders through a Random Algorithm executed by GeM system.
14. In a category based bid, adding additional items, through buyer added, additional scope of work/ additional terms and conditions/or any other document. If buyer needs more items along with the main item, the same must be added through bunching category based items or by bunching custom catalogues or bunching a BoQ with the main category based item, the same must not be done through ATC or Scope of Work.

Further, if any seller has any objection/grievance against these additional clauses or otherwise on any aspect of this bid, they can raise their representation against the same by using the Representation window provided in the bid details field in Seller dashboard after logging in as a seller. Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.
