1. The minimum average annual financial turnover of the bidder during the last three years, ending on 31st March of the previous financial year, should be as indicated above in the bid document. Documentary evidence in the form of certified Audited Balance Sheets of relevant periods or a certificate from the Chartered Accountant / Cost Accountant indicating the turnover details for the relevant period shall be uploaded with the bid. In case the date of constitution / incorporation of the bidder is less than 3-year-old, the average turnover in respect of the completed financial years after the date of constitution shall be taken into account for this criteria.

2. Years of Past Experience required: The bidder must have experience for number of years as indicated above in bid document (ending month of March prior to the bid opening) of providing similar type of services to any Central / State Govt Organization / PSU. Copies of relevant contracts / orders to be uploaded along with bid in support of having provided services during each of the Financial year.

3. **Purchase preference to Micro and Small Enterprises (MSEs):** Purchase preference will be given to MSEs having valid Udyam Certificate and whose credentials are validated online through Udyam Registration portal as defined in Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 dated 23.03.2012 issued by Ministry of Micro, Small and Medium Enterprises and its subsequent Orders/Notifications issued by concerned Ministry. If the bidder wants to avail themselves of the Purchase preference, the bidder must be the manufacturer / OEM of the offered product on GeM. In respect of bid for Services, the bidder must be the Service provider of the offered Service. Traders are excluded from the purview of Public Procurement Policy for Micro and Small Enterprises and hence resellers offering products manufactured by some other OEM are not eligible for any purchase preference. Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered product or service, and Buyer will decide eligibility for purchase preference based on documentary evidence submitted in case of product bids, whereas in case of services the eligibility is automatically validated. If L-1 is not an MSE and MSE Seller (s) has / have quoted price within $L-1+ 15\%$ (Selected by Buyer) of margin of purchase preference /price band defined in relevant policy, such MSE Seller shall be given opportunity to match L-1 price and contract will be awarded for 100% (selected by Buyer) percentage of total quantity. The buyers are advised to refer the [OM_No.1_4_2021_PPD_dated_18.05.2023](#) for compliance of Concurrent application of Public Procurement Policy for Micro and Small Enterprises Order, 2012 and Public Procurement (Preference to Make in India) Order, 2017. Benefits of MSE will be allowed only if seller is validated on-line in GeM profile as well as validated and approved by Buyer after evaluation of documents submitted.

4. Estimated Bid Value indicated above is being declared solely for the purpose of guidance on EMD amount and for determining the Eligibility Criteria related to Turn Over, Past Performance and Project / Past Experience etc. This has no relevance or bearing on the price to be quoted by the bidders and is also not going to have any impact on bid participation. Also this is not going to be used as a criteria in determining reasonableness of quoted prices which would be determined by the buyer based on its own assessment of reasonableness and based on competitive prices received in Bid / RA process.

OPTION CLAUSE 25% : The buyer can increase or decrease the contract quantity or contract duration up to 25 percent at the time of issue of the contract. However, once the contract is issued, the contract quantity or contract duration can only be increased up to 25 percent. Bidders are bound to accept the revised quantity or duration.

Whole genome sequencing of bovine samples - Oxford Nanopore Technology Long-Read (30X)

1. Total number of samples : 6
2. Sample Type provided : Whole blood
3. DNA Isolation & Quality Control: Ultra-High Molecular Weight (uHMW) gDNA extraction is mandatory (SDS-based or phenol-chloroform protocol). QC by Agarose Gel / PFGE, Nanodrop, Qubit, and Fragment Analyser. A comprehensive DNA QC report must be provided.
4. A data coverage of 30X should be provided (with a minimum of 90 GB data per sample).
5. Library Preparation: Oxford Nanopore Ligation Sequencing Kit (SQK-LSK114 or later). No aggressive size selection that removes reads < 10 kb; full-length HMW fragment distribution must be preserved. Library QC by Qubit and Fragment Analyser; library QC report is mandatory.
6. Sequencing Platform: Oxford Nanopore PromethION (preferred) or GridION. R10.4.1 flow cells (or later) must be used.
7. Base-calling: Super-accuracy (SUP) model using Dorado v0.5 or later. Minimum per-read accuracy Q20 (99.0%) after SUP base-calling. Mean read N

50 ≥ 50 kb; target ≥ 100 kb (ultra-long). Active pore count and N50 per flow cell must be reported.

8. Target Coverage: Service provider should target 30× coverage for a genome size of approximately 3 Gb, generating a minimum of 90 GB of high-quality data per sample. Higher depth is required due to the elevated interbreed heterozygosity of the crossbred animal.
9. Data Delivery: Data should be provided via FTP and on hard disk in compatible formats without additional cost. Deliverables must include: POD5 (or FAST5) raw signal files + SUP-called FASTQ.gz + sequencing summary log; MD5 checksums for all files. The sequencing data should be submitted to NCBI/SRA by the service provider on behalf of the user. The required bioinformatics analysis of the generated data must also be done and results should be given in standard required format.
10. Quality Reports : A comprehensive post-sequencing QC report including: total yield (Gb), read N50, mean Q-score, active pore count, and pass/fail read statistics per flow cell; and k-mer spectrum analysis (GenomeScope2) for genome size and heterozygosity estimation.
11. The cool chain / dry-ice should be maintained while collecting the samples without any extra charges.
12. Failed samples after QC check must be collected without additional charges.
13. Free sample pick-up from NDRI; results must be delivered within 30 working days of sample receipt acceptance.
14. Compliance with Indian Biodiversity regulations.
15. The company must have experience in handling ONT long-read sequencing for bovine / buffalo genome projects and should be supported with a P. O. from an institute of repute.
16. The service provider should have an in-house ONT sequencing facility in India. An installation certificate of the ONT PromethION / GridION instrument in India is mandatory.
17. The complete scope of work should be performed by the vendor within India.
18. The laboratory should hold CAP / NABL / DSIR accreditation.
