Purchase preference to Micro and Small Enterprises (MSEs): Purchase preference will be given to MSEs as defined in Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 dated 23.03.2012 issued by Ministry of Micro, Small and Medium Enterprises and its subsequent Orders/Notifications issued by concerned Ministry. If the bidder wants to avail the Purchase preference for services, the bidder must be the Service provider of the offered Service. Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered service. If L-1 is not an MSE and MSE Service Provider (s) has/have quoted price within L-1+ 15% of margin of purchase preference /price band defined in relevant policy, then 100% order quantity will be awarded to such MSE bidder subject to acceptance of L1 bid price.

 2. Two similar completed services costing not less than the amount equal to 50% (fifty percent) of the estimated cost; or
 3. One similar completed service costing not less than the amount equal to 80% (eighty percent) of the estimated cost.

2. Past Experience: The Bidder must have successfully executed / completed supply of similar equipments at least 50% of the Estimated Bid Value to any Central / State Govt. Organization / PSU / Public Listed Company during last two years.
3. Scanned copy of undertaking that the bidder has never been declared Bankrupt/insolvent by any bank/financial agency of central or state government.
4. F.O.R.:- ICAR-NDRI, Karnal
5. Jurisdiction:- In case of any dispute, area of jurisdiction will be Karnal (Haryana).
6. Payment on bill basis after installation of Equipment
7. TDS as applicable will also be deducted from the bill of the firm at the source.
8. In cases of any dispute, the decision of Director, ICAR-National Dairy Research Institute, Karnal shall be final.
9. The Director, ICAR-NDRI, Karnal reserves the right to reject any or all Tenders in whole or in part without assigning any reason thereof. The decision of Director, ICAR-NDRI, Karnal shall be final and binding on the Contractor/ Agency in respect of clause covered under the contract.
1. The firm/contractor should provide the material as per requirement and experience for required item as determined by the Institute or its representative/end user.

11. Creating bid for items from irrelevant categories.
12. Incorporating any clause against the MSME policy and Preference to Make in India Policy.
13. Reference of conditions published on any external site or reference to external documents/clauses.
14. Asking for any Tender fee / Bid Participation fee / Auction fee in case of Bids / Forward Auction, as the case may be.

Further, if any seller has any objection/grievance against these additional clauses or otherwise on any aspect of this bid, they can raise their representation against the same by using the Representation window provided in the bid details field in Seller dashboard after logging in as a seller within 4 days of bid publication on GeM. Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.
